- 2. (a) Security amount be deposited in favor of Registrar, RWU as earnest money which will be refunded to the un-successful parties. The CDR of the successful parties will be detained till the completion of the contract.
  - (b) The payment of the bill will be made after the verification and inspection of the material through the crossed cheque after deducting 5% security from the total value of the bill till the completion of 03 months warranty period which will be released after the verification of end user.
- 3. Late offers will not be considered. Cutting/overwriting is not allowed.
- 4. Single stage/two envelops bidding procedure will be adopted as per PPRA Rules 38-2(a). The envelop shall be marked as "TECHNICAL PROPOSAL & FINANCIAL PROPOSAL" in legible letters separately. The financial proposal of the bids found technically non-responsive shall be returned unopened and shall be returned on the expiry of grievance period or the decision of the complaint, if any, filed by the non-responsive bidder, whichever is later.
